Subject: Letter of Intentality Certificate under Rule 44
of the Delhi School Education Act, 1973.

Sir,

With reference to your application on the subject
above, I am directed to convey the decision of the
Board of School Education, New Delhi, to your school by way of a new middle
school (without aid) in Panchsiri Vihar Area
New Delhi, subject to the following conditions:-

1. That the provisions of the Act, 1973 and the rules
and regulations shall be observed by the society.

2. That the management of the school will fulfil all the
conditions of the Law under Rule 50 and will provide all
the facilities as provided in Rule 51 of the Act, 1973 to the
school.

3. That the management of the school will get the scheme of
aid approved from the department immediately.

4. That only qualified and trained teachers will be appointed
and their salaries along with allowances will be paid
by the school by bank drafts or cash cheques.

5. That the management of the school will not ask for
subsidies from the department.

6. That the school will not be for the profit of any
individual or a group of persons.

7. That in case at any time the management of the school
has any movable or immovable property, the same shall be
transferred to the name of the Director
of Education, New Delhi.

8. That the management of the school will apply for
recognition of the school under the Act and Rules, 1973
and recognition will not be granted unless statutory
provisions of Sec. 4(1) (a) to (f) read with rules 50 and 51
are complied with.

9. That all the recognised schools shall be run at one
place only.

10. That the management of the school shall be taken from the DDA in the name of the Society through the DDE of Education, Delhi.

11. That the school shall run under the control of Little Angels Public School Society (Regd), Delhi and will make efforts for the school site on the recommendation of the Directorate of Education and will construct and operate the building within the three years of taking over of the site from the DDA and adequate and sufficient accommodation of 12 sq. ft. per student shall be provided for class-rooms. Normal size of the class-room is 24' x 27'. No other activity other than education shall be run.

If recognition for the proposed school is not given after fulfilling all the above conditions within a period of 3 years, this permission to run a new school shall be cancelled.
